## THE 2015-16 ACCOUNTS OF NATURAL RESOURCES WALES

I am writing to inform you regarding the progress of my audit of the 2015-16 annual accounts of Natural Resources Wales (NRW).

Under paragraph 23(5) of the Natural Resources for Wales (Establishment) Order 2012, I am required to examine, certify and report on the statement of accounts of NRW. In particular, I am required to lay a copy of the certified statement of accounts and my report on the accounts no later than four months after the statement of accounts is submitted to me. NRW submitted its accounts on 23 August 2016 so, to meet the statutory deadline, I should lay the certified statement of accounts together with my report by 23 December 2016.

Unfortunately, I have concluded that it is not possible to meet this deadline without incurring a significant risk to fairness to third parties. My audit has encountered some significant issues concerning contracts entered into by NRW, and it is necessary in order to be fair to those concerned outside NRW (as well as NRW) that I provide reasonable opportunity to comment on my findings in line with the principles of natural justice.

I should also mention that the issues encountered are legally complex and have necessitated NRW gathering a significant quantity of documentation, which has taken nearly two months. It has also been necessary for WAO staff to review that documentation on my behalf and obtain external legal advice on the issues.

I recognise that missing the deadline for laying my report is unsatisfactory but, in the circumstances, I think it would be even more unsatisfactory to omit to provide those concerned outside NRW (as well as NRW) with reasonable opportunity to comment before laying and publication.

I am aware that the Public Accounts Committee is intending to hold an oral evidence on the annual accounts of NRW during the spring term. My audit team will liaise with the Clerks on the optimum timing for that evidence session.

Given their respective roles, I am copying this letter to the Chair of the Climate Change, Environment and Rural Affairs Committee, the Chief Executive and Accounting Officer of NRW, and the Additional Accounting Officer for the Welsh Government sponsor division.
