  - (a) undertaken an assessment of the impact of the provisions of the Trade Union and Labour Relations (Consolidation) Act 1992 to be disapplied by section 1 on devolved Welsh authorities during the period of two years following the commencement of those provisions, and
  - (b) laid a report of that assessment before the National Assembly for Wales.'

  - (a) cynnal asesiad o effaith darpariaethau Deddf yr Undebau Llafur a Chysylltiadau Llafur (Cydgrynhoi) 1992 a gaiff eu datgymhwyso gan adran 1 ar awdurdodau datganoledig Cymreig yn ystod y cyfnod o ddwy flynedd ar ôl cychwyn y darpariaethau hynny, a
  - (b) gosod adroddiad o'r asesiad hwnnw gerbron Cynulliad Cenedlaethol Cymru.'
