I want this new law to help children and adults in Wales who have autism get the support they need.



I am calling this law the **Autism (Wales) Bill** or **the Bill** for short.



I have until **13 July 2018** to write the Autism (Wales) Bill. It will then be looked at by other Assembly Members, who will decide if it should become a law.



I want to know what you think should be in the Bill. I want your thoughts and ideas please.



When the Bill is first written I will give everyone the chance to read it and have their say again.

In this document I have written about:



- what I want this Bill to do
- what I think should be in the Bill
- why I think we need this Bill.

Your answers will be read by me and staff at the **National Assembly for Wales**.

### What is autism

Autism is the short name given to a range of disorders known as Autistic Spectrum Disorder (ASD).



Sometimes people with autism are known as autistic people.

People with autism may also have other things like:



a learning disability




- a mental health condition.



In this document I will use the term 'people with autism.'

## Aims of the Autism (Wales) Bill

I want the Bill to:



 Make the Welsh Government write an autism strategy. The strategy will say how services should meet the needs of people with autism in Wales.

A **strategy** is a plan that says what we will do to achieve our aim to get people with autism the support they need.



 Make the Welsh Government write guidance about how to follow the autism strategy.

**Guidance** is advice and information. It will be written down. It will help to explain what the law is. And it will say how the autism strategy is to be followed.



Make it easier to get an autism diagnosis.

A **diagnosis** is when a doctor looks at a person's health and behaviour and says whether they have autism or not.



 Make sure local authorities and health services help people with autism to get the support they need when they need it.



 Find a way of getting information about how many people have autism and what their needs are. This is to make sure support is planned properly.



 Make sure staff who work with people with autism have training.



 Make sure local authorities and health services give information about the services they offer for people with autism.



 Make the Welsh Government keep checking the autism strategy and guidance to make sure they are working.



• Help people to better understand the unique needs of people with autism.



 Make sure adults with autism and parents and carers of children with autism take part in the making of the autism strategy and guidance.

# Why we need the Autism (Wales) Bill



There has been a lot of work done over the last few years to make services for people with autism better.



In 2008 Welsh Government wrote the **Autism Spectrum Disorder Strategic Action Plan**. And they updated it in 2016.



A lot of good things happened because of this plan. But more still needs to be done.

I believe we need this new Bill so that local authorities and health services:



 understand what they need to do to give the best support for people with autism



keep up the good work of the Strategic Action
 Plan. And keep making services better for people with autism



 have a duty under the law to make services better.



England and Northern Ireland already have laws that say their governments must write an autism strategy and guidance.



I believe that Wales should have a law that says Welsh Government must write an autism strategy.



This autism strategy would help to make sure that there will always be good services for people with autism in Wales.



I believe this law should also say that Welsh Ministers must write guidance to go with the autism strategy.



I believe that the law should say that local authorities and health services must follow this guidance.

# Getting a better way to diagnose autism



For lots of people getting an autism diagnosis makes it easier to understand what support they need and get services.



I believe that if we have a law that says how we must organise getting a diagnosis for autism, people will be able to get a diagnosis easier. And they will get it when they need it most.



The law would say that local authorities and health services **must** organise a clear way of getting a diagnosis.





People with autism usually get support from Learning Disability teams or Mental Health teams.



But autism is not a learning disability. And it is not a mental health problem.



Sometimes a person with autism may have a learning disability or a mental health problem.



But quite often people with autism are turned away from services because they do not have a learning disability or a mental health problem.



This often means that people with autism do not get the support they need.



I want this law to stop this from happening. Services cannot turn people away because they have a high level of intelligence (IQ) for example.



I want this law to make sure local authorities and health services understand the needs of children and adults with autism and provide services that meet their needs.



At the moment local authorities and health services collect information about learning disabilities and autism in their areas.



They must keep a register of children with disabilities in their area. They may do this for adults too.



But this information might not be very reliable. And different information is collected in different ways in different areas of Wales.



There is also a risk that people with autism who do not have a learning disability will not get the right services.



I want this law to stop this from happening. I want local authorities and health services to collect information about people with autism separately. They must plan their services to meet these needs.

## **Autism training for staff**



I want the law to make sure that the staff who need it get autism training.



Llywodraeth Cymru Welsh Government

I know a lot of staff have already had autism training thanks to Welsh Government projects.



But I think that this law should make sure that staff get the same results from training.



I think that this would make it easier to set **standards** on their autism training. And to check that staff had the right **standard**.

A **standard** is a level of skill or understanding.



I think this would also help to make sure staff got ongoing training.



I think it is best for the guidance to say what the **results** of autism training should be. Instead of just saying what the training should be.



I think this will help services provide the right kind of autism training for their staff.



## Jobs for people with autism

The Welsh Government has been doing work to help get more people with autism jobs.



But still not many people with autism have jobs. We need to do more.



Under the new **Strategic Action Plan 2016-2020** the Government wants to improve education and work for people with autism. They plan to do this by:



 running a project called Getting Ahead to help young people with autism get work;



becoming an autism friendly employer;



 working with bosses and support staff so they know more about autism.



#### The definition of autism

A **definition** of autism is an explanation of what autism is.

The definition could be written in:



• the law (Bill) itself



in the autism strategy



or in the guidance.



I think the definition should be written in the autism strategy, so that it can be updated when needed.



If it is written in the Bill it would be hard to update it in the future.

## How much money my Bill may cost

Most laws cost money in some way. I think the things that will cost money in this law will be:



getting information and writing an autism strategy;



 checking and updating the autism strategy and telling people about the changes;



writing and giving out the guidance;



 the extra things local authorities and health services will need to do because of this law;



 finding a way to get information about how many people have autism and what their needs are;



training for the staff who need it.



The Social Services and Well-being (Wales) Act 2014 already says that local authorities must give people with autism and their families and carers:



- information services;
- advice services;
- support services.



Local authorities could give information about their services for people with autism as part of this. This would not cost much more money to do.



The Refreshed Autistic Spectrum Disorder Strategic Delivery Plan 2016-2020 also says that health services must give advice and support to all people with autism and families and carers.




I do not think it would cost much more to include awareness raising too.

## How my Bill might save money



Sometimes new laws can help save money.



The **National Audit Office** wrote a report about supporting people with autism.



The report said that if people with autism had the right support, the Government could save money in the long term.

# Other things to think about



It is important that this Bill does not have a bad impact for people. I will look into how this Bill may affect:

people with autism



- support services staff
- organisations
- other people.
