# 1. Chairs' welcome, introduction and apologies

# 2. Presentation on the Draft Report on the Inquiry into the Armed Covenant in Wales – Darren Millar AM

The Chair led a discussion on the draft report on the Inquiry into the Armed Covenant in Wales. The executive summary of recommendations were each read in turn so that the group could discuss.

He also provided an update on current plans under way for the RAF Centenary Celebrations to be held at the National Assembly in April 2018.

There was discussion on the need to plan a Royal Navy event, as there have been no navy experience dates so far. The army and RAF have both had two events each to date at the Assembly.

Commodore Dai Williams raised a celebration event at the Lloyd George Museum on 1<sup>st</sup> December which is being held to mark the Act of Parliament that created the RAF.

# 4. Presentation on Families of Veterans Support Service (FVSS) – Karen Rees

Karen Rees from Barnado's Cymru gave a presentation on the Families of Veterans Support Service.

Karen outlined the project which is the result of Covenant funding.

The presentation was followed with a question and answer session. This included FVSS's involvement with Public Health Wales, the number of ACE's of referred children to the service and the effect of imprisonment on children. Karen outlined the work that is being done in conjunction with HMP Parc and the Endeavour Unit.

Annabel Ingram from the Army Families Federation (AFF) updated the group on a briefing produced by AFF on the Service Pupil Premium.
